### **RULES FOR BUS TRANSPORTATION**

- 1) The bus annual fees are settled in three payments in September, in January and in April.
- 2) In case of cancellation of bus registration, the bus company will apply the UAE Law Chapter 5 Article 52 under Article 8 A, B, C and D to refund the payments.
- 3) There is no rate for one way.
- 4) The bus routes and stops are defined at the beginning of the year.
- 5) The children are not necessarily dropped in front of their building; one assembly point for students can sometimes be appointed.
- 6) Any change in the address during the year, parents must inform the company at least one month ahead. A place is not automatically guaranteed. It depends on the availability and the location.
- 7) Children are not allowed to use other bus than the one they usually take. They are also not allowed to be dropped off at another bus station than the one they usually stop at.
- 8) The timetables and the scheduled stops must be respected.
- 9) Parents are not allowed to get inside the bus. For any complaint, they should contact the bus company in charge.
- 10) Children shall be accompanied by someone responsible during pickup and drop off (If child's temperature exceeds 37.5, he/she will not be allowed to take the bus).
- 11) Children must be seated according to their given seat number by the bus nanny.
- 12) Children must maintain social distancing, use hand sanitizer, and always wear facemask.
- 13) Parents are responsible for any damage caused by their children on the bus.
- 14) The bus company will expel students from the buses if they have three written warning reports.
- 15) Students from Kindergarten till 11 years old must be accompanied by an adult at the bus stop.
- 16) When returning home they have to be attended by an authorized person from the family. If this person is not present at the bus stop, the driver will continue his way and will bring the student back to school where his families have to come and pick him up.
- 17) The bus transportation service is only in charge of the students while him/her present on the bus.
- 18) For security reasons, students must be quite and calm during the bus rides and must:
  - Put their seat belts
  - Respect the equipments/ No pushing or horseplay /Stay seated during the bus ride/ No screaming, No fighting/ No food or drinks / Follow instructions of the bus nanny and respect regulations.
- 19) Any failure to follow these rules may lead to the exclusion of students taking the bus.
